# Parsons Marsh

Parsons Marsh is part of the Undermountain Valley, a wetland and forest area in the heart of Lenox. Berkshire Natural Resources Council, the Town of Lenox, and private landowners have partnered to conserve this land for farmland soils, wildlife habitat, and recreation. BNRC's 183 acres now offer an accessible trail that is half hardpacked surface and half boardwalk.

**Directions:** 170 Under Mountain Road, Lenox From Lenox: From the center of Lenox, head south on Main St. Turn right at the 1st cross street onto MA-183 S/West St and follow for 1.4 miles. Turn right onto Under Mountain Rd. The trailhead is 0.9 miles down the road on the right.

Accessibility Details: The Parsons Marsh Trail was designed and built in 2018 to U.S. Forest Service trail accessibility standards (FSTAG). The first 600-feet of trail features crushed stone surfacing with a running slope not exceeding 8% and a cross slope not exceeding 5%. An accessible picnic table and bench are provided on a short spur near the pond. The last section of trail is comprised of 900-feet of curbed boardwalk, with a 41" passable width and grades not exceeding 7%.

# PARSONS MARSH TRAIL MAP

### TRAIL DESCRIPTION Trail: 1/3 mile, one-way Difficulty: Accessible

On the 1,800-foot (1/3 mile) accessible trail, you will wind through an open meadow to a small pond, then into forested upland and vegetated wetland. Rest on the bench or picnic on the accessible table near the pond. Just beyond the pond, the trail transitions to boardwalk as it enters the forested wetland. The trail ends at an observation platform which provides open views from the edge of the marsh.

The Parsons Marsh trail and boardwalk were designed and constructed by Peter S. Jensen & Associates, LLC.

### **NATURAL HISTORY**

Admire pollinators in the meadow, look for amphibians by the pond, seek skunk cabbage in the wetland, and spot some of the 75 nesting bird species that have been identified at Parsons Marsh. The marsh and surrounding water bodies provide habitat for beaver, mink, and otter. The forest in the southern part of the property is dominated by white pine but also includes such hardwoods as red maple, sugar maple, and black cherry. To the south you'll find large rock outcrops, remnants from the glaciers of 20,000 years ago.
